Remember the dead and fight for the living on International Workers Memorial Day. UNISON at UK level is campaigning for government recognition of the Day. UNISON member Cathy Peattie MSP is tabling a motion in the Scottish Parliament calling on MSPs to support WMD.

UNISON believes that there needs to be a cultural change in the way work related deaths, injuries, and ill-health are viewed. They are not just part of the job, or just unfortunate. In most cases they are also avoidable. Official recognition of the Day will bring us a step closer towards universal condemnation of the tragic and preventable loss of life, injury, and ill-health. This in turn may lead to better enforcement of existing health and safety laws, and thereby better health and safety at work.

Violence against public service staff

Dave Watson and Scott Donohoe reported to the last meeting of the Scottish Health and Safety Committee on their meeting with the minister, Shona Robison MSP on extending the Emergency Workers Act and further measures under the Government's Safe at Work Campaign.

The minister agreed to consider the list of additional workers we want to see covered by the Act and announced new initiatives to strengthen workplace measures in health and local government. The committee will be following up these issues in the coming months.

Over 1000 persons have now been prosecuted under the EWA. Not bad considering the view of the legal establishment that the Act wasn't necessary!

Scottish Civil Courts Review

UNISON Scotland has responded critically to a review of civil courts in Scotland headed by Lord Gill. Speakers at a recent STUC conference attacked many aspects of the review that could seriously undermine the ability of trade unions to pursue personal injury cases.

We are concerned not only about the content of this review but over the process and underpinning principles upon which the review is based. We are concerned that key conclusions in the Civil Justice Review have been reached before the issue even went to consultation. We are therefore equally concerned over the extent to which this agenda will be followed irrespective of the consultation response. The narrowly drawn membership of the review, excluding other key stakeholders, gives us little confidence in the review outcome.

Personal Injury Cases 2008

UNISON Scotland raised 558 personal injury cases last year and won nearly £2 million in damages for members.

Trips, slips and falls remained the largest single cause of injury. Other significant case types included manual handling, road traffic and needle-stick injuries. The number of criminal injury cases remains low compared with the number of recorded assaults and branches are reminded to advise members to make a claim.

Corporate Homicide

The new Corporate Homicide provisions came into force in Scotland on 6 April. STUC General

Secretary Grahame Smith has strongly criticised the adequacy of these provisions. He said:

“This legislation will not allow for prosecution of individuals, but only of the company. Even then, only if the failures of a senior manager can be identified”.

For the STUC, and the victim’s families, this is a fudge of the “controlling mind” test that has made the prosecution of companies so difficult in the past”.

The Scottish Government has put off a decision on Scottish legislation to strengthen the provisions. Commenting on this decision Grahame said:

“Is waiting for a negligent employer to cause a workplace fatality the Scottish Government’s vision of delivering justice to victim’s families?”

Government’s at UK and Scottish level appear reluctant to take firm action under pressure from big business. The campaign goes on.
